#### Personal Information

## Non-Personal Information

We may also collect non-personal information such as:

- Browser and device information
- Website usage data
- Cookies and similar technologies

We use your personal information for the following purposes:

- To communicate with you and respond to your inquiries
- · To process donations and issue receipts
- To manage our volunteer and staff programs
- · To provide you with information about our programs, events, and activities
- To improve our services and website
- To comply with legal and regulatory requirements

- Regular security audits and assessments

## **Data Retention**


